I, Joel B. Ard, Esq., pursuant to 28 U.S.C. § 1746, hereby declare as follows:

- 1. I am admitted to practice law in this Court and the Courts of the State of Washington. I am the sole member of Ard Law Group PLLC ("ALG"), counsel of record for Class Representative Chris Hunichen ("Hunichen"), and appointed Class Counsel. I respectfully submit this declaration in support of the Class Representative's Motion for an award of fees and expenses.
- 2. I have personally participated in, overseen, and monitored the prosecution of this Action, and have otherwise been kept informed of developments in this Litigation. Thus, if called upon, I can testify to the matters set forth herein.
- 3. My firm has served as co-Class Counsel for the Settlement Class throughout the course of this litigation.
- 4. As noted in my Declaration of December 13, 2022, I previously spent 1,152 hours working on this matter, which, at my then-regular hourly rate of \$775, corresponded to a lodestar of \$892,800.
- 5. This Court's prior Order awarding fees in connection with the Partial Settlement resulted in ALG recouping approximately 75% of ALG's total lodestar.
- 6. Since December 2022, I have spent an additional 110.3 hours working on this matter, which, at my current regular hourly rate of \$850, corresponds to a lodestar of \$93,755. This summary was prepared from contemporaneous, daily time records I regularly prepare and maintain. The hours and lodestar amount were for the benefit of the certified Class.
- 7. Ard Law Group has also reimbursed JND Class Action Administration, the Courtappointed administrator in this matter, for \$9,397.50 in costs for class notice and administration as required by this Court's class certification Order (Dkt No. 246), and in giving notice of the Preliminary Approval of this settlement. These costs are separate from notice and administration costs incurred in connection with the earlier Partial Settlement, and relate only to the separate Litigation Class, now the subject of this settlement.
