DECLARATION OF WILLIAM R. RESTIS  
IN SUPPORT OF CLASS  
REPRESENTATIVE'S MOTION FOR AN  
AWARD OF ATTORNEYS' FEES AND  
EXPENSES

1 I, William R. Restis, Esq., pursuant to 28 U.S.C. § 1746, hereby declare as follows:

2 1. I am admitted to practice law before the Western District of Washington *pro hac*  
3 *vice*. I am the Chief Executive Officer of THE RESTIS LAW FIRM, P.C. (“RLF”), counsel of record  
4 for Class Representative Chris Hunichen (“Hunichen”), and have been appointed Class Counsel  
5 for the Settlement Class. I respectfully submit this declaration in support of the Class  
6 Representative’s Motion for an award of fees, and expenses.

7 2. I have personally participated in, overseen, and monitored the prosecution of this  
8 Action, and have otherwise been kept informed of developments in this Litigation. Thus, if called  
9 upon, I can testify to the matters set forth herein.

10 3. Provided below is RLF’s total hours and lodestar, computed at current rates, from  
11 May 19, 2017 through the signing of this declaration. The total number of hours spent by RLF  
12 during this time period was **1,384.1 hours with a corresponding lodestar of \$1,043,481.50**.  
13 This summary was prepared from contemporaneous, daily time records regularly prepared and  
14 maintained by RLF. The lodestar amounts reflected below are for the benefit of the Settlement  
15 Class and certified Class. The hourly rates for myself and support staff are RLF’s regular hourly  
16 rates, which are based on comparable rates charged by firms in the field of securities litigation  
17 and approved by courts in connection with contingency fee applications by plaintiffs’ counsel in  
18 similar securities litigation matters.

19 4. Attorneys and Professional Support Staff at RLF billed the following aggregate  
20 hours to this matter as of the date of filing, with fees applied at RLF’s current billing rates:

5. This Court's prior Order awarding fees in connection with the Partial Settlement resulted in RLF recouping approximately 61% of RLF's total lodestar.

6. RLF has also reimbursed JND Class Action Administration, the Court-appointed administrator in this matter, for \$9,397.49 in costs for class notice and administration as required by this Court's class certification Order (Dkt No. 246), and in giving notice of the Preliminary Approval of this settlement. These costs are separate from notice and administration costs incurred in connection with the earlier Partial Settlement, and relate only to the separate Litigation Class, now the subject of this Settlement.

7. I have reviewed the time and expenses reported by RLF in this Action which are included in this declaration, and I affirm they are true and accurate.
